## LETTER OF CONTRACT

In the event of notice of termination or termination the Second Party shall take immediate steps to bring the services to a prompt and orderly conclusion, including return of equipment and files if any belonging to the First Party.
5. The First Party reserves the right to amend or alter from time to time, the job description to suit its requirements.
6. That all intellectual property created or contributed to, directly or indirectly, solely or jointly with others during the employment shall be the property of First Party and the Second Party assigns all copyright, if any, in any intellectual property to First Party.
